6. Submission of false or fraudulent documentation will result in disqualification from this and any future Epson promotion.

7. Closing date for submission of all customers' proof of purchases is no later than 1st September 2008 for the claim to be valid.
8. In the event the customer returns the Epson product (to the reseller) on which the FREE 4 year warranty cover is being claimed, the customer will no longer be entitled to the FREE 4 year warranty.
